- 4. The tenders related to all work subjects can be obtained from the building section of Ratnapura Gatangama Provincial Education Department on weekdays from 9.00 hours to 3.00 hours from December 28, 2023, to January 17, 2024.
- 5. For that, the non-refundable fees mentioned in Table 1 (column 5) above must be submitted between 9.00 a.m. and 15.00 p.m. and received from the Additional Provincial Education Director (Finance) of the Provincial Education Department. Payment must be made in cash.
- 6. All bidders shall submit their bids in duplicate, and the documents obtained for a bid bond or deposit in accordance with the conditions of procurement shall be submitted along with the original copy of the bid documents. Also, the relevant work subject should be mentioned in the top left corner of the bid cover.
- 7. The bid shall be valid for 90 days from the date of bid opening. (The exact date is mentioned in the bid documents.)
- 8. All bids must be accompanied by the refundable bid security mentioned in column 06 of table 01, in cash or from a bank approved by the Central Bank of Sri Lanka, in the name of the Director of Provincial Education, Provincial Education Department, Gatangama,

Ratnapura, and the said bid security must be valid for 120 days from the date of opening of bids. (The exact date will be mentioned in the bid documents.)
